20. Mr.Anil Garg is working as Managing director of "CLS Packaging Limited" He is not in favour of selling waste materials in the market. Instead he is planning to make himself new products of this material. For this purpose, a new unit will have to be set up. Accordingly, he decided to establish this unit in an area where large number of persons are unemployed and so labour is available at cheap rate. In order to attract workers to this new unit a special remuneration scheme was introduced. As per this scheme, workers will get their remuneration on the basis of their work. There will be two rates of wages higher wage rate and lower wage rate. A worker who will work up to a given standardized units or beyond will be paid his/her remuneration at a higher rate. On the other hand, a worker who will work less than the given standardized units will be paid his/her remuneration at a lower rate. In order to operate this new unit Mr.Garg established a separate 'Waste material division' it consisted of four departments such as purchase, sales, production and accounts. Company required four managers to run these departments, of these two managers were appointed from the existing business, by way of promotion while the other two were selected out of the waiting list maintained by the company.
